



SERVICE FLOW

Net Protections is a company that provides Buy Now Pay Later (BNPL) services. BNPL is a payment method that allows customers to make purchases immediately and pay for them later.



Customer benefits

No credit card is necessary. Purchase can be made quickly and easily without risk of information leakage. Stable cash flow due to extended payment terms.

SERVICES



For online shopping

A BNPL service for online shopping intended for BtoC transactions. Pay for the product after delivery, and there is no need to register as a member or enter credit card information.



For on-site services

A BNPL service for on-site services such as equipment repair and housekeeping. Payment can be made after the service is provided. No cash preparation on the day of service is required to use.

For online and in-store purchases

A BNPL service for both online and in-store purchases. Users can make purchases immediately and pay for them later without registering a bank account, credit card, or adding funds.



For BtoB transactions

A BNPL service for BtoB transactions. We are an intermediary between the merchant and the customer, handling all the settlement operations from credit, invoicing, and payment collection. We also cover the risk of unpaid invoices.



For overseas markets

A localized BNPL service for Taiwan and Vietnam. Member registration is not required and one may use it for both online and offline purchases.

360 degree evaluation
